#### Statewide survey: Most say government should publish public notices in newspapers

Results of a statewide Wisconsin Public Notice Readership Survey indicate nearly 78 percent of residents believe state and local government should continue to be required to publish legal and public notices in newspapers on a regular basis.

The Wisconsin Newspaper Association commissioned its first-ever statewide public notice survey, conducted by Newton Marketing & Research, to update knowledge of and better understand what's on the minds of Wisconsin citizens when it comes to public notice.

"Wisconsin newspapers have always served as the independent, trusted conduit between government and its citizens," WNA Executive Director Beth Bennett said. "The results of this survey clearly reflect Wisconsin residents' desire for that relationship to continue."

Survey interviews were made by telephone to a random selection of 500 households throughout Wisconsin. A team of trained interviewers worked evenings during the survey period, Aug. 9-27, 2010.

Newton Research, of Norman, Okla., is a market research company specializing in media usage, consumer behavior and product feasibility.

Notable statewide public notice survey findings follow:

- 77.8 percent of Wisconsinites believe state and local government should be required to publish legal and public notices in the newspaper on a regular basis.
- 89 percent of Wisconsin households surveyed never go to the public library to use the library's computer system to access news or information on local or state government.
- 76.8 percent of Wisconsinites believe that public notices should continue to be published in community newspapers as a means of independent verification and government oversight.

- 82.6 percent of Wisconsinites surveyed read or look at a newspaper that is published in their community or neighboring community.
- 63.4 percent read a newspaper that is published daily.
- 85.5 percent of Wisconsinites participating in the survey voted in a recent election.
