## County attorney seeks commissioners' approval of resolution prepared by Attorney General's office to investigate and review Glacier County Treasurer

"You can't cure a crime. The recall election doesn't change anything," stated Glacier County Attorney Carolyn Berkram during the May 5 meeting of the Glacier County Commissioners. On April 26, Berkram submitted an agenda item advising the commissioners to approve a resolution from the Montana Attorney General's Office. The resolution appoints the Prosecution Services Bureau of the Montana Department of Justice as special counsel "in the investigation and review of County Treasurer Mary Ann Boggs as it relates to Official Misconduct."

At last week's meeting, Berkram questioned who revised the agenda item regarding the resolution that was prepared by the Attorney General's Office and why. "The intent of the Attorney General's Office is to investigate and possibly prosecute Mrs. Boggs and they would like the resolution signed by the commissioners," stated Berkram.

A Freedom of Information request was made by this newspaper to obtain a copy of the email sent by Berkram requesting the matter be placed on the agenda. The email was addressed to Commissioner DesRosier, as well as County Commissioners Ron Rides At The Door and Tom McKay and Clerk and Recorder Glenda Hall.

The email was very brief and requested: "Please place the following on the May 5, 2016, agenda at 10 a.m.: Discussion/Approval: Resolution Glacier County Attorney's request for prosecutorial assistance from Prosecution Services Bureau of Montana Attorney General's Office regarding investigation and re-

view of Treasurer."

When the May 5 agenda was posted, it did not include anything about the resolution. It was listed as: Discussion: Glacier County Attorney's request for prosecutorial assistance from Prosecution Services Bureau of Montana Attorney General's Office regarding investigation and review of Treasurer." It also did not include the requested time of 10 a.m.

Commission chairman Michael DesRosier said he "wanted to see what it is about" before the commissioners approved the resolution. The email was sent at 12:26 p.m. on April 26, which was 10 days prior to the May 5 meeting.

# It's official: Voters recall Boggs

Glacier County voters were shouting for change when they cast their votes in the May 3 recall election of Glacier County Treasurer Mary Ann Boggs. They voted overwhelmingly to recall Boggs by a vote of 1,785 to 360. Those official results were released shortly before 4 p.m. on May 9 after three provisional ballots were counted and canvassed yesterday.

There was not one precinct in the county where Boggs received more "against" the recall votes than "for" it.

Elaine Mitchell, who spearheaded the recall petition, spent the entire Election Day in the county's satellite office in Browning, observing the election process. "The staff in Browning did an excellent job. I had no idea what the outcome would be," said Mitchell who returned to Cut Bank to observe the ballot counting procedure.

"The ballot box from Browning was delivered to the courthouse at 8:34 p.m. but not one ballot was counted until 1:21 a.m. It was 4:11 a.m. when the last ballot was counted and shortly before 4:30 a.m. before we received the result, which was overwhelmingly in favor of recalling the treasurer. The voters were paying attention. Doing the right thing for the right reasons paid off."

Election workers were "sequestered" while they opened and certified ballots on Election Night. The public was only allowed to observe the counting of the ballots, which began after 1 a.m.

According to the first set of unofficial results released on May 4, 1,744 voters voted "yes" to recalling Boggs and 325 voted against the recall.

Once the election results are declared "official" Boggs will be removed from office and the commissioners will need to appoint an interim treasurer.

According to Hall's unofficial tally on Monday, May 9, the total number of ballots distributed was 4,607 and the number of ballots returned was 2,149 for a voter turnout of 47 percent.

### Recall.

A handful of concerned citizens paced the halls of the Glacier County Courthouse waiting for results of the election. Five hours after the polls closed election officials had yet to count the first ballot. It took nearly a dozen "sequestered" election workers in the courtroom of the Glacier County Courthouse that long to open and certify the approximately 2,100 ballot ballots.

Once that was done, shortly after 1 a.m., Hall attempted to feed the tri-folded ballots into the relatively new ESS DS850 voting system scanner and tabulator. Since it kept jamming, election workers attempted to "smooth" out the bal-

lots. Hall finally resorted to feeding the ballots five at a time into the machine.

The recall petition against Boggs was approved on Sept. 9 and within 90 days over 1,400 people signed the petition in favor of recalling the first term treasurer.

Reasons cited for recalling Boggs included incompetence for violating her oath of office by failing to discharge her duties, official misconduct by negligently failing to perform mandatory duties, failing to submit cash reports, failing to submit district revenues and reports to the School Districts in Glacier County, and failing to respond to public record requests.
